### Education and Experience

Jennifer Munson received her Master of Science in Oriental Medicine from Southwest Acupuncture College in Boulder, CO in 2014. The three-year accelerated program included over 3000 hours of didactic and clinical education and over 900 hours of clinical practice. She is certified as a Diplomate of Oriental Medicine with the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM), which includes certification in Acupuncture, Chinese Herbology, and Clean Needle Technique. Jennifer's training includes adjunct therapies such as moxibustion, Oriental bodywork techniques (tui-na, shiatsu, hara), cupping, gua sha, electrical stimulation (e-stim), auriculotherapy, and dietary and lifestyle recommendations. Jennifer is a licensed acupuncturist in the state of Colorado and is in good standing with DORA and NCCAOM. None of these licenses, certificates, or registrations have ever been suspended or revoked.

This clinic complies with the rules and regulations of Colorado's Department of Regulatory Agencies (DORA). Proper sanitation and sterilization of medical equipment and cleaning of the surrounding office are strictly adhered to. Only single-use, disposable, factory-sterilized needles are utilized.
